40 YEARS OF REPRESENTING SINGAPORE'S TECH INDUSTRY

2022 sees SGTech celebrating 40 years since its inception as the Singapore Federation of the Computing Industry (SFCI) in 1982. To kick off the celebrations, we were honoured to have Minister for Communications and Information Josephine Teo unveil the 40th anniversary commemorative logo at the Techblazer Awards Ceremony in January 2022.

While we celebrate our heritage, we are mindful that our raison d'être is to represent our members. SGTech's focus is advocating for our members; our goal is to spearhead initiatives that create opportunities for Singapore's tech industry and contribute to placing Singapore on the world map for tech.

ADVOCATING FOR THE INDUSTRY

We are heartened to report that some of SGTech's recommendations to the government for Budget 2022 were included in the announced measures. They include: the COMPASS Framework for Employment Pass holders, continued enhanced support under the Productivity Solutions Grant, and waiving the Skills Development Levy contribution as a criterion for the SkillsFuture Enterprise Credit, enabling micro and small enterprises to utilise it.

We ensured the industry's voice was heard in engagements on government procurement, the pilot Data Centre – Call for Application Exercise (DC-CFA) and the Public Consultation on Strengthening Protections for Platform Workers. We have also advocated at the international arena via our participation in the APEC Business Advisory Council (ABAC) and the Association of Computing Industry Organisations (ASOCIO).

TRANSFORMING FOR THE FUTURE WITH LEAD SUPPORT

Outside of advocacy, SGTech's focus in the past year was on operationalising our three-year transformation plan. Centre to the plan's execution is a multi-year, multi-million-million-dollar programme of work under the LEAD umbrella, being supported by Enterprise Singapore. The projects to be funded are aligned with our three strategic thrusts.

Strategic Thrust 1: Positioning Singapore as a Global Digital & Data Node, Built on Trust

One of the pillars of this thrust is to develop tech, people and governance capabilities and relationships in the budding digital trust space to further solidify Singapore's leadership as a global node for digital and data.

We announced the Digital Trust Committee in September 2021, with Senior Minister of State Tan Kiat How as the Patron of the Committee. The Committee has kicked off an ambitious global Digital Trust Landscape Study which has solicited views of over 80 local and international thought leaders combined with secondary research. This seeks to map the state of play for digital trust globally and identify opportunities in this space for Singapore to strengthen its global digital & data node status ambitions.

Another pillar of this thrust is forming a Digital Transformation Centre, which will develop a holistic approach towards digitalisation encompassing Strategy, Skills and Solutions. It aims to engage over 1,500 companies in their digitalisation journey over the next three years.

Supporting our work with companies is a partnership with the Singapore Business Federation to assist 50 trade associations and chambers (TACs) in building their digital capabilities and leveraging them to support companies.

Strategic Thrust 2: Tech as a Driver of Sustainability

SGTech wants to inspire and rally businesses to collaborate and steer Singapore's tech industry toward the Singapore Green Plan 2030 targets.

eRevival Square 2021, our sustainability community outreach pilot with member Sustainable Living Lab, launched in July 2021 to raise awareness of the reuse and repair of electrical appliances among consumers and businesses. The project was named 2021 Runner-Up for Global Public Service Team of the Year in Climate Category by Apolitical, a global multi-governmental funded non-profit championing public sector innovation.

With Senior Minister of State for Sustainability and the Environment Dr Amy Khor as the Patron for the SGTech Sustainability Steering Committee, we have expanded our sustainability agenda to embrace e-waste, circular economy, ESG reporting, green infrastructure, food tech and green energy.

Strategic Thrust 3: Tech Talent to Power the Singapore Economy

Against the backdrop of the global tech talent shortage, we must build a steady stream of talent to power Singapore's tech industry and other sectors.

Following a successful pilot, SGTech is collaborating with Workforce Singapore to launch a scaled-up tech career services programme to assist close to 600 career switchers through support groups, workshops and speed interviews.

We also co-designed a skills-based apprentice programme for graduates of the polytechnics and ITEs. Under the TechSkills Accelerator for ITE and Polytechnics (TIP) Alliance with IMDA, we will match participants with employers. The initiative will bridge 1,000 students with tech companies in the next three years.

GRATITUDE AND FORGING AHEAD

I thank all members for your active participation and look forward to your continued involvement in our initiatives. To the past and present Councillors and Exco members of the Steering Committees, Chapters and Committees, I sincerely thank you for your contributions. Let us continue to forge ahead together and build a bright future for Singapore tech.

We continue the association's 40th Anniversary celebrations in the new financial year with a Gala Dinner that Deputy Prime Minister Heng Swee Keat will grace in September 2022 and the inaugural SGTech Global Future Series: Digital Trust Forum in October 2022. Please join us.

A FRESH LOOK AND UPDATED NARRATIVE AT FORTY YEARS

On the occasion of the association's fortieth year, and as part of the alignment with our three-year transformation plan, SGTech embarked on a refresh of our SGTech brand and narrative. The outcome of the brand refresh includes an updated set of vision and mission statements to reflect our direction and a refreshed logo with a new tagline, "Where Tech Meets".

WHERE TECH MEETS

To ensure that SGTech continues to be a place where tech meets, we set up new interest groups to better support our growing community of Tech@Core members, such as the Platform Companies Committee comprising Amazon, Deliveroo, Foodpanda, Gojek, Grab and TADA.

Riding on a broader mix of interest groups, activities and representation across more tech verticals, we welcomed more members into our fold this year. We breached the 1,000-member mark for the first time, closing the year with 1,065 members, an increase of 27.86% from FY20/21.

INCREASED GOVERNMENT ENGAGEMENTS AND VISIBILITY IN MEDIA

With clarity in our three strategic thrusts, we set about driving the advocacy for our thrusts. With the support of the members of the Council, Steering Committees, Chapters and Committees, we actively engaged the relevant ministries and agencies to convey and rally support for our ideas and initiatives.

We hosted three CXO in Conversation events in the year, engaging Minister for Trade and Industry Gan Kim Yong, Senior Minister of State for National Development Tan Kiat How and Minister of State for Trade and Industry Alvin Tan. SGTech also held engagement sessions with senior leaders of government ministries and agencies.

SGTech also saw more of our initiatives reported in the media this year. The business and trade media also published our views in interviews and opinion pieces.

ELABORATED WORKSTREAMS FOR STRATEGIC THRUSTS

Cyber security is crucial in furthering Singapore's positioning as a global digital and data node. We continued to build on ongoing work with the Cyber Security Agency of Singapore and are one of the pioneering advocates for CSA's SG Cyber Safe Partnership programme.

On sustainability, under the leadership of our member volunteers, five workstreams have commenced, covering: ICT asset life extension for SMEs, electrical appliance life extension for consumers, packaging innovation for ICT devices, ESG-compliant procurement education for SME suppliers, and outreach and education to encourage broad-based acceptance of tech-produced food.

Continuing our work to build the talent pipeline, SGTech facilitated over 1,000 internships for students with tech companies under the Global Ready Talent programme during the year.

SECRETARIAT EXPANSION TO DEVELOP AND GROW NEW PRODUCTS

The disruption from the Covid-19 pandemic cast the spotlight on the degree of resilience and continuing viability of our traditional flagship events. While we are grateful that we could continue holding the CXO in Conversation series in a virtual (and now hybrid) format and resume Infocomm Leaders Golf in 2021, as part of SGTech's transformation, we want to create new products that are relevant to our time. Leveraging the LEAD-funded programme of work, SGTech will develop new product houses that will become the future flagship projects.

Firstly, the SGTech Global Future Series. The inaugural SGTech Global Future Series: Digital Trust Forum in October 2022 will provide a platform for industry leaders, policymakers and thought leaders to come together and discuss the future of the digital economy around the anchoring issue of trust. It will be a launchpad for several large-scale action plans arising from the Digital Trust Landscape Study. This event will be co-branded with ASOCIO's annual Digital Summit and supported by the APEC Business Advisory Council (ABAC), a testament to SGTech's work in helping position Singapore as a global leader in digital trust, driving impactful and actionable outcomes together with influential regional partners.

Another initiative in the works is a multimedia publication – TransformLife.SG multimedia publication. The project is an update to the book "Intelligent Island: The Untold Story of Singapore's Tech Journey Intelligent Island book", which was published in 2017. Much has changed since the publication of the book. Digital technology is constantly in constant motion to transform the way we live and work. TransformLife.SG will be driven by the tech community-driven project. We will engage the members of the tech community to map the Singapore tech industry's milestones of the tech industry, draw out the lessons learnt to be learned in our technological journey, and provide thought leadership and insights into trends and issues that shape the industry.

To power these new engines of growth for SGTech, we have restructured the Secretariat. We have formed two new divisions – Membership Engagement to ensure that we engage our growing member base and remain relevant to our members, and Government Affairs & Strategic Partnerships to strategize strategies, manage and advocate for our members to key stakeholders. In the coming year, we will set up a new Research team that will generate insights for members and support our advocacy. We have also added headcounts to existing teams to support the growth in volumes across the board.

APPRECIATION

I want to express my appreciation to our member representatives, past and present. You have generously contributed your leadership, resources and know-how to bring SGTech to where it is today.

With everyone's involvement, we will continue to build and support the largest tech community in Singapore, where companies converge to advocate for change and drive what enables tech innovation and accelerates tech adoption. We want to make our refreshed brand messaging a continuing reality.





TOWARDS A MORE TRUSTED GLOBAL DIGITAL ECOSYSTEM

Positioning Singapore as a leading global digital and data node, built on trust, is one of SGTech's strategic thrusts. This is because we believe that in today's rapidly digitalising and interconnected world, understanding Digital Trust and how to capitalise on its opportunities and mitigate its challenges is an imperative for anyone interacting in the digital economy

Digital Trust is a growing area of interest that concerns governments, businesses and citizens worldwide. It has the power to accelerate digital trade and power the global digital economy. Yet despite its potential as an influential catalyst for the digital economy, it has been difficult to define common standards for Digital Trust, or understand how best to leverage it for a competitive advantage.

This is why SGTech established the Digital Trust Committee in September 2021. This committee, chaired by Mr Philip Heah and with Senior Minister of State, Tan Kiat How, as its Patron, has been leading high impact initiatives throughout the year to better understand Digital Trust, articulate its importance to stakeholders in our digital ecosystem, and identify ways to harness its significant potential.

Singapore has long been a trusted global hub for business, aviation and finance; we hope that our work can help accelerate Singapore's journey to becoming a global hub for Digital Trust too.

MAKING A REGIONAL IMPACT WITH DIGITAL TRUST ADVOCACY

The achievements made and the momentum built by SGTech and the Digital Trust Committee in the past year have been helped significantly by our Patron, Senior Minister of State (SMS) Tan Kiat How, who has been an ever-present and influential supporter of our events and initiatives. SGTech is humbled that SMS Tan recognises the value SGTech's work can bring to Singapore's digital economy, and honoured to be able to benefit so regularly from his counsel and guidance.

SMS Tan was particularly instrumental in guiding the late stage government socialisations of our Digital Trust Landscape Study and will be an active participant in the SGTech Global Future Series: Digital Trust Forum in October 2022, where he will host a roundtable on Digital Trust, and help us launch a number of future SGTech initiatives in his role as Guest-of-Honour.

Throughout the year, SGTech has been an influential voice in the APEC Business Advisory Council (ABAC), where our Chair Wong Wai Meng acts as the Digital Work Group Co-Chair for the Cross-Border Privacy Rules (CBPR) workstream.

At the 3rd APEC Business Advisory Council (ABAC) meeting in Ha Long, Vietnam from 25 - 29 July 2022, Wai Meng shared with ABAC members on how SGTech's work on Digital Trust is closely aligned to the APEC region's digital agenda to facilitate more seamless trusted cross border digital flows. In addition to sharing the high-level

interim recommendations from our Digital Trust Global Landscape Study, SGTech's call for regional action was clear: the ABAC business community has the agency to take tangible steps to build trust amongst businesses, large and small, to facilitate greater trusted cross border data flows using existing standards and certification systems like the CBPR and linking them to local trustmarks to boost adoption rates.

ABAC's unanimous support to co-launch SGTech's Digital Trust Centre of Excellence (CoE) during the Digital Trust Forum in October is a rousing endorsement of the value SGTech's work on Digital Trust is bringing to the region, and is a clear manifestation of how SGTech is actively working to position Singapore as a global digital and data node, built on trust.

SGTech has furthered its regional influence on Digital Trust through our continued partnership with- and active participation in the Asian-Oceanian Computing Industry Organization (ASOCIO), an ICT federation representing 17 countries and economies in the region. Recognising the importance of Digital Trust to boost digital trade in a post-Covid era, the ASOCIO Board is co-funding a Digital Trust White Paper on behalf of their member economies, and ASOCIO will also be holding its annual General Assembly and 64th Board Meeting as part of a parallel programme alongside the SGTech Global Future Series: Digital Trust Forum. We look forward to welcoming the ASOCIO delegations in October.

SURVEYING – AND CHANGING - THE GLOBAL LANDSCAPE OF DIGITAL TRUST


Key Initiatives & Successes

The biggest initiative of the newly-formed Digital Trust Committee in the past year was to commission a global Digital Trust Landscape Study, an ambitious, large-scale research project that got underway in February 2022.

Guided by our Digital Trust Exco, with Royce Wee (Alibaba Cloud) as project lead, this study set out to define Digital Trust, describe the current international landscape for Digital Trust, identify enabling factors for it, analyse the opportunities it offers Singapore – including a deepdive market sizing forecast – and issue a set of detailed recommendations for government and industry to follow up on.

After more than 70 interviews with industry leaders and policymakers around the world, supported by comprehensive secondary research, the team conceived a framework of 11 'Digital Trust Enablers' in the three

domains of Technology (e.g. GRC and Digital Identity solutions); Governance (e.g. data privacy and ethics, regulation and certification); and People (e.g. a Digital Trust Workforce). Our findings suggest that, leveraged well, Singapore's Digital Trust market could grow from SG\$1.7bill to SG\$4.8bill between now and 2027, adding 30,000 new jobs in the process.

The final report will be released to the public in October 2022 as part of our next big initiative – the inaugural 'SGTech Global Future Series: Digital Trust Forum'. This conference, for which the Digital Trust Exco and Secretariat has been working hard on throughout the year, is Asia's first dedicated conference on Digital Trust issues and will provide an essential platform for global thought leaders, policy makers and industry leaders to further discourse in the area.

LAYING THE LAND IN PREPARATION FOR WHAT IS TO COME



Sustainability Committee Meeting 25 Jan 2022 hosted by Sustainability Living Lab

We had our first sustainability community gathering in May 2021. We focus strategically on e-waste, packaging, circular economy, green building, and green IT standards. Since then, we have been laying the ground for our members to be ready to meet global sustainability goals that call for incorporating measurable change in business decisions and practices.

Of our initial strategic foci identified, we have drilled down into specific areas and secured the support of Enterprise Singapore to roll-out proofs-of-concept that demonstrate the viability of effecting collective shifts in business and consumer behaviours and practices towards SG Green Plan 2030 targets.

We have also expanded our strategic focus to look at ESG reporting as a whole, food and agri-tech, as well as emissions baselining to help enable broad-based energy resets.

Our sustainability strategies are now articulated clearly with specific SG Green Plan 2030 targets. In addition, we have mapped the UN Sustainability Development Goals that we could achieve through our proofs-of-concept to keep SGTech, and consequently Singapore's tech industries, abreast with global developments.

WINS & SUCCESSES



SEEDING AWARENESS IN THE 2RS OF E-WASTE

We began with awareness creation at home to build mindshare and broaden business buy-in of the need for Singapore to level up our two Rs of e-waste reduction: repair/refurbish and reuse. By extending the lives of our electrical and electronic devices and appliances, we help reduce the amount of e-waste going to our landfills while alleviating the stress on our recycling sectors.

Our eRevival Square initiative was launched on 25 July 2022. Based on the concept of "revival", i.e. extending the life of our e-products, eRevival Square kicked off with a virtual pledge wall signed by over 30 businesses to combat e-waste, and officiated and launched by Dr Amy Khor, Singapore Senior Minister of State for Sustainability and Environment. In the following five months from July to December 2021, SGTech worked on-hands in dynamic partnership with vibrant SGTech Member, Sustainable Living Lab (SL2), and stalwart supporter SGTech member Meta Singapore (Meta SG), to implement a series of weekend repair community workshops livestreamed on

Facebook, as well as an #E-WASTENOMORE challenge to upcycle or repair e-products complete with cash prizes.

Over 800 consumers onsite and over 23,700 consumers online were engaged, over 10,000 online viewers watched our live workshops, corporate pledgee NEC was featured via online interview and video feature, and in January 2022, eRevival Square was voted as the 2021 Runner-Up Global Public Service Team Of The Year by Apolitical, a global multi-government funded education service for public sector and policymakers.

CHAMPIONING THE GREENING OF DATA CENTRES

The booming digital economy across Asia Pacific and increasing rates of digitalisation in business and personal lives are set to continue to increase. This will continue to raise, not reduce or even maintain the status quo of, the global demand of data centres as the infrastructural backbone of our world tomorrow.


Singapore is currently a leader in the Asia Pacific data centre market and ranks second globally with over 70 operational data centres providing a total available IT capacity of about 1,000MW, according to Singapore's Ministry of Trade and Industry. This puts Singapore far ahead of developed Asia Pacific cities Hong Kong and Sydney.

By necessity, data centres run round-the-clock in temperate-controlled environments, and everything they use from servers, storage equipment, to cooling infrastructures, require large amounts of electricity. Estimates suggest that data centres globally are responsible for up to 5% of global greenhouse gas emissions, while data centres in Singapore are estimated to consume 7% of our nation's electricity produced.

This means that every time we bank online, log into our company networks – even watch a streamed show on Netflix or Disney+ during our weekends – we consume data traffic, which in turn consumes power, puts out emissions, and adds to global warming.

With the recent lifting of regulatory moratorium on the construction of new data centre capacity in Singapore, SGTech supported Amazon Web Services to lead the way in rallying Singapore's data centre industry to discover and pilot greener means of increasing Singapore's total data capacity without adding to emissions and energy consumption. Furthermore, we invited experts from TÜV SÜD to share on the ISO/IEC 22237 standard which can lead to the improvement of the energy efficiency and sustainability of their DCs.

Going forward, SGTech will continue to organise and facilitate on-going exchange between experts, regulators and industry to find ways to green our data centres and support the growth of the global digital economy from Singapore.

GOING INTO A NEW FY AND BEYOND

However, awareness is only the beginning of the sustainability transformations that are looming on Singapore's near horizons. Our next challenge lies in rallying our members to tackle industry-wide issues in a by-industry-for-industry approach, as we pilot proof-of-concept to demonstrate that what is commonly thought to be insurmountable can be done.

Joining our bold endeavours is Dr Amy Khor, who has accepted our invitation to guide and help us as our Patron of Sustainability with effect from our next financial year. With her invaluable leadership and experience onboard, we are excitedly gearing up to work closely with her and her ministry to rally industries, businesses, and peoples to collectively overcome obstacles and adopt new practices for reducing our environmental footprints.

Our first area of focus will be in procurement, to sandbox a method by which large corporates are able to derive attainable baselines for SME suppliers to level themselves up for competing in ESG-compliant tenders. We aim to discover learning points and achieve outcomes that could start businesses large and small to look at greening their respective supply chains.

Our second area of focus will be in ICT packaging, where we are set to drive dialogue between regulators and industry to discover gaps and ways of reducing packaging used in the sale, storage, and transport of ICT devices, or increasing the content of renewable materials used.

Thirdly, we are further expanding eRevival Square to onboard a pilot group of SMEs into firm-level training for extending their IT asset lives and management, with the aim to enable SMEs to identify and unlock cost savings from fixed assets.

We secured strong financial support from Enterprise Singapore to defray portions of our variable costs in implementing the above proofs-of-concept and look forward to strong industry support to work with us to realise our visions.

Last but not least, to strategically amplify the impact of our efforts, we are gearing up to reconstitute SGTech Sustainability Committee as a strategic steering committee with effect from our next financial year. Through the steering committee, we are positioned to articulate and cascade our strategic goals and initiatives down to the tech sectors we serve, chapter by chapter, committee by committee.




CHAMPIONING THE GROWTH OF THE TECH TALENT WORKFORCE

Over the past five years, SGTech has consistently championed the need for policies and programmes that grow the tech talent workforce in Singapore to fuel innovation and drive digital transformation across all sectors.

Working closely with government agencies in constructive dialogue on work pass policies, SGTech has advocated for more openness to global talents via a more precise skills-based approach, with differentiated criteria based on the in-demand and strategic jobs critical to Singapore's development. The Complementarity Assessment Framework (COMPASS) announced at Budget 2022 is an example of a step in the right direction.

SGTech also sees the importance of giving back to the local workforce. Our Talent Steering Committee has a clear vision to help every Singaporean who wants to join the tech sector to have an opportunity to do so. Our focus is on growing the pool of tech talents by co-creating and executing programmes for students and career switchers. Having already placed close to 3,000 locals in internships and jobs across more than 650 companies, we are continuing to expand our suite of support services with Workforce Singapore via our Tech Career Services for career switchers and with IMDA for a new apprenticeship programme called the TechSkills Accelerator (TeSA) for ITEs and Polytechnics (TIP) Alliance to further proliferate more skills-based education and career pathways.

THE IMPORTANCE OF SKILLS-BASED HIRING

Over the past few years, SGTech has advocated for greater adoption of skill-based (vs. qualifications-based) hiring as a means to ensure local workforce adaptability to meet the rapidly evolving needs of tech jobs. This has become even more important when it comes to supporting Singaporean career switchers and students entering tech jobs for the first time. While qualifications and experience will always be valuable, assessing candidates based on skills and holistic competencies, rather than their last job title can pave the way for the workforce to adapt more quickly.

Skills-based hiring prioritizes individuals' technical abilities and core competencies over academic credentials. This approach requires recruiting teams to objectively define and evaluate required skills to reduce bias in the hiring process. Skills-based hiring also assists firms in bringing on a more diverse and inclusive staff, providing a comprehensive picture of employees that incorporates talent and skill into how companies build their teams.

Building on the principles of skills-based and more holistic hiring practices, two new initiatives were announced this year that focus on strengthening the tech workforce in Singapore.

COMPASS evaluates Employment Pass (EP) applications based on a holistic set of individual and firm-related attributes. This enables employers to select high quality foreign professionals, while improving workforce diversity and building a strong Singaporean core. It is a transparent system that gives businesses greater clarity and certainty for manpower planning. Given the acute shortage of tech talent in Singapore, we are glad that MOM had taken in SGTech's industry feedback and is moving towards greater transparency and a more targeted approach to the EP framework.

internationalisation activities

Within the framework, there are two bonus criteria which SGTech is looking forward to making further contributions to, i.e., skills bonus (Shortage Occupation List) and strategic economic priorities bonus by

- working with IMDA and MOM to define the tech sector jobs to be included in the Shortage Occupation List (SOL),
- proposing a pilot trial for skills-based testing to complement the academic qualifications criteria
- expanding the list of "Strategic Economic Priorities Bonus" to include companies that make additional efforts to support the local workforce, e.g., through career conversion, apprenticeship, and internship programmes.

2. TECHSKILLS ACCELERATOR FOR ITE AND POLYTECHNIC ALLIANCE INITIATIVE




The TechSkills Accelerator for ITE and Polytechnic (TIP) Alliance is a new initiative by Infocomm Media Development Authority (IMDA) aimed at providing students and graduates from Singapore's polytechnics and Institute of Technical Education (ITE) with end-to-end support in kick-starting their careers in the tech sector. First announced by then-Minister of State for Communications and Information Tan Kiat How in March 2022, this initiative aims to provide a structured, end-to-end approach to better support our polytechnic and ITE students in securing tech-related jobs.

It will include private sector internships to allow students to acquire in-demand skills such as those of data engineers, database administrators and application developers. After graduation, the ITE and polytechnic graduates will be able to take up apprenticeships at participating companies under place and train programmes, to learn the ropes for information and communications technology (ICT) roles. Participating companies will also establish skills-oriented training plans and career pathways for tech roles for these graduates. These may also include certifications and specialist training. These graduates can also have the option to continue taking up further ICT qualifications such as a diploma and/or degree while working with their employers, through SkillsFuture Work-Study programmes.

This initiative will start with 1,000 students over the next three years. By providing structured support and clearly defined career pathways for the ITE and Polytechnic graduates, the TIP aims to address some of the hiring preferences, especially for suitable entry-level ICT roles, that some employers tend to have i.e., university graduates.

This is also critical to address the issue of the rising shortage of tech talent especially when the ITE and Polytechnic graduates account for more than half of the graduates from tech courses every year. SGTech will be working closely with industry and IHL partners to place and nurture this group of young talent.





TECHBLAZER AWARDS 2021

24 Jan 2022 - The Techblazer Awards 2021 ceremony was held at Suntec City Convention Centre and graced by Guest of Honour Mrs Josephine Teo, Minister for Communications and Information. The Techblazer Awards is jointly organised by IMDA and SGTech.

Over 250 guests attended both in-person and remotely, to witness the selected winners out of 440 submissions, up from 403 in 2020.





GROWING INDUSTRY INTEREST AND SUPPORT

SGTech Chair, Mr Wong Wai Meng, in the welcome address, expressed his gratitude for the community of entrepreneurs, business leaders and industry partners who are committed to advocating for tech entrepreneurs and young tech talent.

Citing SGTech's partnership with Oracle, he thanked Oracle for generously sponsoring US\$30,000 worth of Oracle Cloud credits to 40 participating companies of the Techblazer Award, as part of Oracle's earlier announcement to support startups.

Mr Wong also thanked industry partners who have offered support to our Techblazer participants in the form of training, mentoring, business matching and funding opportunities. THOUGHTS ON WINNING AT THE APICTA AWARDS

Solution: Augmentus

Mr Daryl Lim, Co-Founder, Augmentus:

I had a great time meeting the various startups around the region and pitching to the panel of distinguished judges. It gave me the opportunity to connect with the judges personally and explore potential synergies to collaborate together.

Prior to starting Augmentus, my co-founder and I built robotic solutions for leading advanced manufacturing companies. After personally experiencing heavy fragmentation and other difficulties during the process, it inspired us to build a fully autonomous robot programming platform that drastically reduces the programming time from weeks to minutes.

Augmentus is an Al-robotics platform that enables fully autonomous digital twin creation and robot motion planning, enabling non-technical operators to programme robot systems in minutes.

We are also looking to raise our next investment round to scale deployments.

Solution: SafeEntry

Mr Daryl Low, Assistant Director, GovTech:

Joining the APICTA awards this year allowed for more open discussion of innovative ideas with the region, to not only to share best practices, but to learn from others as well.

SafeEntry was built to resolve the need for effective and practical visitor management, and have control measures deployed at all public locations to allow citizens to move about the community amidst growing concern for the spread of COVID-19.

As SafeEntry stabilises, there is a greater push for privatesector collaboration and co-creation.

We will continue to innovate and enhance the SafeEntry experience to minimise friction against adjusting to the new-normal for our citizens, visitors and businesses alike.

Solution: Mapping Platform

Mr Ajay Bulusu, Co-Founder, NextBillion.ai:

As a young start-up that's looking to revolutionise enterprise mapping, the APICTA awards presented a great opportunity to compare ourselves with some of the biggest names in the ICT industry. This was an incredibly valuable experience, as it gave us a better idea of where we currently stand and what we can do to advance ourselves.

One map doesn't fit all. Maps were always built for individual end users, not enterprises. Through our solution, we are bridging this gap to help enterprises succeed better with targeted solutions.

Moving forward, we are making investments across artificial intelligence, machine learning and computer vision, and we expect to drive significant innovation in mapping.

Solution: Newton's Meter

Mr Siddharth Mazumdar, Founder, Newton's Meter (NM SGP Pte Ltd):

Participating in the APICTA awards was quite an eyeopening experience for me. Preparing the materials to become a finalist allowed me to better articulate my ideas in the written word, augmenting my communication skills.

The final presentation, in particular, stood out to me. The questions asked by the judges were incisive and insightful and I was able to glean useful feedback from the session.

The APICTA awards also provides exposure to technology leaders across the region, allowing nominees to lean on their experiences.

We are now looking into greater retail and distribution channels in more diverse markets, industrial installations in the offshore, logistics, and healthcare industries, as well as Research and Development (R&D) for military use and preventive accident management.

VIRTUAL MEET-THE-MEMBERS SESSION

9 Dec 2021 - SGTech hosted more than 100 industry leaders at a virtual Meet-the-Members session, and gave an overview of SGTech's Three Year Transformation Plan.

Mr Wong Wai Meng, SGTech Chairman, explained the objective of the plan - to ensure the organisation remains future-ready and relevant to members and wider committee, and for SGTech to transform as an association to serve a broader base of companies.

The two strategic thrusts Mr Wong highlighted were:

- To become a global node for 'digital and data', built on trust. Steps taken include the formation of a Digital Transformation Centre to guide companies through the process.
- For the tech sector to achieve these goals sustainably, both locally and globally.

However, Mr Wong emphasised that SGTech must continue to champion for **Talent for Tech** which will underpin the strategic thrusts.

Ms Yean Chong, SGTech Executive Director, elaborated on SGTech's transformation plans and focused on improving engagement with members. According to Ms Yean, SGTech's Chapters and Committees will form the building block of this transformation, while the Steering Committees will ensure the entire organisation stays aligned to the strategic thrusts.

MULTIPLE OUTREACH EFFORTS

SGTech also announced the publication of a second volume of "Intelligent Island: The Untold Story of Singapore's Tech Journey" as a digital-only book. While the first volume was a look-back to Singapore's tech journey, the second volume will be a look-ahead at the possibilities in the future.

SGTech's Corporate Social Responsibility (CSR) activities will become an "Always On" platform. This will expand SGTech's capacity to support themes that are meaningful, throughout the year.

- **Digital Transformation Chapter:** Site visits to companies to find out how they have embraced digital transformation and learn best practices
- Singapore Enterprise Chapter: Mentorship workshops in collaboration with universities, polytechnics and ITEs
- Smart Nation Chapter: Partnership with Smart Nation Chapters from other geographics to form a constellation of like-minded partners, to increase regional access

VIRTUAL NETWORKING

CHALLENGES IN DIGITAL TRANSFORMATION

To give members a chance to share their latest technologies and solutions, SGTech's Digital Transformation Chapter (DxC) held multiple networking sessions over coffee, with a total of 24 members attending sessions between April and May 2022. The sessions were sponsored by EZ-Link Pte Ltd.

The sessions were organised by DxC Excos Dr Mark Shmulevich, DxC Chair, Mr Nicholas Lee, DxC 1st Vice-Chair, EZ-Link Pte Ltd, James Miner, DxC 2nd Vice-Chair, Minerlabs Group Pte Ltd, and Mr Julian Chan, Co-opted ExCo, Microsoft Operations Pte Ltd.

Discussions ranged from the tech talent shortage, to general challenges in digital transformation. Members were reminded of the DxC's Chapter Vision - that successful digital transformation requires an agile mindset, openness to collaboration, digital-ready talent, awareness and adoption of best practices.

INVOLVING STAFF AT ALL LEVELS

Members raised the lack of buy-in from employees, hindering efforts to digitally transform their organisations, and shared that involving them in the decision process are critical factors contributing to ensuring the project's success.

MULTIPLE APPROACHES TO TRANSFORMATION

Members also discussed various approaches to streamlining and accelerating the digital transformation process.

- Encouraging CTO service providers to move beyond consultancy, and to build partnerships with companies instead
- Looking abroad for talent, including considering shifting jobs remotely to remain competitive and connected with the global technology industry.
- Developing the necessary skillsets required by the industry within the current and next-gen Singaporean workforce, through Workforce Singapore programmes and Career Conversion Programmes.
- Resuming in-person international business missions and trade fairs, to improve trust and improve the chances of closing international deals. Global missions are currently headed for China, London, Australia, Thailand, Vietnam, Indonesia, and more.

CXO IN CONVERSATION

The Role of Technology in the Future of Manufacturing



29 Oct 2021 - SGTech hosted the CXO in Conversation series, exploring the role of technology in the future of manufacturing.

Guest-of-Honour Mr Gan Kim Yong, Minister for Trade and Industry, explained to the audience that the manufacturing sector is a top contributor of Singapore's economy, and that the Singapore government's aims to grow the industry by 50% in the next 10 years, in a project called "Manufacturing 2030".

Minister Gan called for an acceleration of digitalisation and automation as part of the new industrial revolution, which he called "Industry 4.0", in order for Singapore to become a global business innovation and talent hub for advanced manufacturing.

THE ROLE OF TECHNOLOGY IN SMART MANUFACTURING

Digital transformation is crucial for manufacturers to stay ahead in the global market. With the economic slowdown due to the pandemic and the resulting supply chain crisis, businesses need greater technological innovation to maintain a competitive advantage.

"To remain in the global manufacturing ecosystem," said Mr Douglas Foo, President of Singapore Manufacturing Federation, "you need smart manufacturing and technologies to build a differential type of business model and create a unique space for yourself."

Mr Terence Teo, President of the Singapore Industrial Automation Association, noted how manufacturers integrated various new technologies like 3D engineering tools, machine learning, augmented reality, big data analysis and cloud computing, to streamline their operational processes.

Despite the clear benefits of digitalisation, adopting technology and digital tools remains a challenge for many businesses. Apart from infrastructural limitations, people and processes often remain key barriers. A mindset shift and improving digital literacy, especially amongst top management, will contribute towards a better understanding of how technology can be effectively used.

AID TO ACCELERATE DIGITALISATION

The government is working closely with Trade Associations and Chambers (TACs) such as SGTech to support businesses' digital transition.

Minister Gan spoke about the "Stronger Together, Aiding Recovery" (STAR) fund, launched by SGTech, with support from Meta and Enterprise Singapore (ESG), to help businesses adopt technology to transform and prepare for the post-COVID economy.

MOVING TOWARDS GREATER SUSTAINABILITY IN MANUFACTURING

"Globally, manufacturing contributes to one-third of global greenhouse gas emissions," said Ms Serene Sia, SGTech Councillor and Managing Director, ASEAN at Autodesk.

"Sustainability cannot be a footnote for the manufacturing sector. Integrating it as part of the overall business strategy helps companies save cost, reduce wastage, and improve efficiency," she said.

Sustainable practices are essential to achieving positive business outcomes and long-term value.

Mr Steven Koh, Executive Director of Singapore Precision Engineering & Technology Association (SPETA), explained: "When it comes to waste management, pollution control and energy conservation, these are often regarded as good to have, but, in fact, are a need to have."

Technological development is paving the way towards more eco-conscious practices.

Increasingly advanced tools such as IoT sensors to monitor carbon emissions, or Al with high image resolution cameras performing quality assessments, help to give an improved overview of the supply chain. Using innovative and intelligent solutions is key to the future of manufacturing.

FILLING THE GAP IN SKILLED TALENT

The panelists also noted a shortage of skilled workers, with 75% of jobs in the local manufacturing sector unfilled last year.

Mr Foo stressed the importance of grooming future talent for the survival of Singapore's manufacturing sector. He described educational initiatives launched by SMF that aim to spark an interest in manufacturing amongst the younger generation, and help them nurture relevant industry skills.

Investment in workforce training and talent development is also important in tackling the talent shortage.

Singapore Polytechnic's Company and Workforce Transformation (CWT) program helps companies looking to grow a skilled workforce and increase occupational mobility.

DEVELOP A THRIVING MANUFACTURING ECOSYSTEM

Collaboration is key to building global resilience. In the global race towards digital transformation, building up Singapore's manufacturing ecosystem by leveraging technology will lead to the sector's healthy growth and success.

Mr Gan stressed the importance of active collaboration with industry TACs to encourage a culture of peer learning and help companies along their transformation journey.

CXO IN CONVERSATION

Building Resilience and Emerging Stronger in the Construction Sector



29 Nov 2021 - SGTech continued the CXO in Conversation series, this time with a focus on the construction sector.

Mr Tan Kiat How, Minister of State, Ministry of
Communications and Information (MCI) & Ministry of

SLOW GROWTH DUE TO THE PANDEMIC

According to the Ministry of Trade and Industry, the construction sector grew 2.8% in 2019. However, much of this growth has now been reversed by the pandemic.

A few key pain points were brought up by the industry experts that companies across the construction sector faced, such as:

- Increased wages and material costs
- Manpower shortages due to closed borders
- Attracting and retaining skilled talent
- Ensuring workplace safety amidst the pandemic
- Transitioning into a remote/hybrid work environment

The speakers and panelists invited the participants to consider minimising disruption in the workplace caused by the pandemic by adopting the following practices:

- Using Bluetooth and artificial intelligence (AI) for contact tracing.
- Ensuring safe management and distancing are effectively practised at work sites.
- Adopting technologies such as the Build SG Covid Safe platform, that highlights potential cases early and allows only approved workers to enter work sites and dormitories.
- Automating manual and complex workflows through solutions such as the five-dimensional building information modelling (5D BIM) and AI.
- Strengthening the organisation's digital infrastructure.

SUPPORTING SMES IN THE NEW WORK ENVIRONMENT

Minister Tan highlighted that the government is committed to supporting companies on their digital transformation journey by providing assistance schemes, such as BCA's Productivity Solution's Grant (PSG), which helps micro and small enterprises adopt easy-to-use digital and productivity solutions.

SGTech has also introduced a 'Stronger Together, Aiding Recovery' (STAR) Fund, which aims to help tech SMEs in

Singapore support the digital transformation of other SMEs. This fund helps companies leverage technology in their preparation and transition towards digital operations in a post-covid economy. Companies can also use this fund to upgrade core competencies through training programmes.

FRAMEWORKS AND INITIATIVES TO SUPPORT THE CONSTRUCTION INDUSTRY

The lack of talent with the right skills is a main challenge for the industry, according to the speakers. BCA and other industry stakeholders have worked towards tackling this issue. In addition, several accreditation schemes were crafted to help companies adopt frameworks and improve the skillsets of their employees.

1. Building a stronger talent pipeline

- Programmes for students to learn about careers in the built environment sector, such as workshops, digital learning journeys, competitions.
- Joint scholarships with firms to attract talent to the industry.
- iBuildSG, a Built Environment Formation Programme to help better prepare students for their internships by providing real-life insights into career choices and pathways.
- Hands-on interdisciplinary workshops in various transformation areas.

2. Upskilling the workforce

- Launched the "Skills Framework for Built Environment" in 2020, under SkillsFuture, to outline the skills and competencies required to progress along different career pathways.
- Accreditation schemes to uplift the professionalism and attractiveness of careers in a built environment while promoting the recognition of skills to support career progression.

Firms were encouraged to continue embracing the skills framework to increase the attractiveness of built environment careers to new entrants, while ensuring the career progression of existing employees.

This, the speakers believed, will collectively improve the industry's growth and ensure a sustainable talent pipeline to develop greater opportunities and jobs for all Singaporeans.

By maintaining a long-term view and continue transforming by leveraging technology, companies raise their productivity and resilience, and the sector will be better equipped to deal with future disruptions.

CXO IN CONVERSATION

Digitalisation and Internationalisation

13 May 2022 - SGTech and Google Singapore co-hosted the first hybrid edition of The CXO in Conversation, featuring a spontaneous fireside chat format, on the topic of whether digitalisation is key for SMEs to harness opportunities in a S\$1trillion Internet economy.

The event was sponsored by Google Singapore and supported by industry players such as Enterprise Singapore (ESG), Infocomm Media Development Authority (IMDA), Bain & Company, and ThoughtWorks.

IMDA presented the existing government support measures that include the SME Go Digital Initiatives as well as the CTO-as-a-Service one-stop platform that SMEs can take advantage of to overcome immediate and long-term challenges.

STRENGTHENING SMES THROUGH DIGITALISATION SET TO CONTINUE

Strengthening SMEs through digitalisation will continue to be a key commitment between the Government, large enterprises, and industry associations, as highlighted in the event theme.

In Singapore, SMEs have been supported heavily by the Government's strong push for digitalisation. It was announced in Budget 2022 that S\$600 million will be dedicated to helping SMEs boost productivity through digital transformation.

With Southeast Asia's digital economy expected to scale to USD\$1 trillion GMV by 2030, digitalised SMEs in the region are among the key benefactors of such trends and developments.

"One of the things we have been helping SMEs is looking at CTO-as-a-Service for SMEs to adopt these technologies in order to digitalise and internationalise," said Mr Alvin Tan, Minister of State for Trade and Industry during the fireside chat moderated by Mr Nicholas Lee, SGTech Councillor.

Given the race towards digitalisation among SMEs in the last two years owing to the pandemic, Minister Tan is optimistic that there will still be an impetus for digitalisation even as borders reopen.

"COVID-19 has helped us to focus our minds on two things - the thrust in our economic plan, centering on digitalisation and sustainability efforts – going Digital and Green," he said.

STAYING AHEAD OF DIGITALISATION TRENDS

Based on the e-Conomy SEA 2021 Report published by Google, Temasek, and Bain & Company, it was found that in Southeast Asia, digital merchants use an average of two digital platforms to access consumer demand online while one in three merchants believed that they would not have survived the pandemic if not for digital platforms. These findings were presented at the event by Mr Aadarsh Baijal, Partner of Bain & Company Singapore.

"From tech startups to micro businesses, SMEs form the backbone of the Singapore economy. Supporting and enabling the digital transformation and growth of these SMEs remains a key focus for us, under our larger commitment to empower Singaporeans today, for tomorrow.

During the pandemic, going online has been a necessity for the business continuity of SMEs across the region, including Singapore. To this end, Google has continued to support these SMEs by investing in digital skills through programmes like the SME Leadership Academy, training over 10,000 SMEs during the pandemic," said Mr Ben King, Country Managing Director for Google Singapore and Councillor of SGTech.

Other event highlights included case studies by Thoughtworks and a panel discussion on how businesses can leverage digitalisation for market growth in Southeast Asia, moderated by SGTech.

"When we look at SME's digitalisation journey, there is certainly no one-size-fits-all approach. We are talking about making this journey effective so that it enhances our lives. Technology is developed because it enhances the way we live, the way we work, the way we play, and this is also about the way we do business," said Yean Cheong, Executive Director of SGTech from the panel discussion moderation.

SGTECH PREPARING SMES FOR DIGITALISATION

As the wave of digitalisation continues to sweep across regions and sectors, SGTech has been partnering with important industry players to relook the focus on digitalisation such that outcomes and strategies adopted by SMEs are well-aligned with their business outcomes.

To guide SMEs through their digital transformation journey, SGTech is also looking at setting up an SGTech Digital Transformation Centre, that will champion the need for a holistic approach suited to the changing business environment.





ENGAGEMENTS WITH TACS

MOU Signing with the Blockchain Association of Singapore

21 March 2022 - To bolster the growing blockchain scene in Singapore, SGTech signed an MOU with the Blockchain Association of Singapore (BAS) to collaborate on certification and talent while furthering knowledge on blockchain technology.

The signing between BAS and SGTech was witnessed by Guest of Honour, Minister of State for Communications and Information Tan Kiat How.

FOCUS ON IMPROVING KNOWLEDGE

Both parties hope to establish a partnership that will bolster the local blockchain ecosystem - by leveraging each other's networks on issues such as blockchain certification and talent-sourcing, as well as furthering knowledge on the technology by hosting various conferences and events.

Mr Chia Hock Lai, Co-Chairman of BAS, said: "As per the recent survey by KPMG1, the majority of cryptocurrency and blockchain deals for Singapore in 2021 went towards software and underlying infrastructure. We are seeing this wave and we foresee blockchain to be a frontrunner in generating jobs in Singapore."

SGTech's Annual Survey identified a growing interest in blockchain applications, with many tech companies identifying blockchain technology as one of their key areas of interest.

Mr Wong Wai Meng, SGTech Chairman, said: "As the largest community serving all companies on their technology adoption journey, SGTech aims to help businesses better understand the use cases of enterprise blockchain, find the right fit in the application that can improve their operations. With the acceleration in blockchain innovation, SGTech will further support businesses in strengthening their digital capabilities with enterprise blockchain solutions built on the pillar of trust."

The partnership with SICCI starts with initiatives led by SGTech's Cloud & Data Chapter.


Mr Gunasekharan Chellappan, Chairman of SGTech's Cloud & Data Chapter, shared the 3-step programme for SICCI members:

SGTECH AND TECHUK MOU OPENS UP OPPORTUNITIES

25 Feb 2022 - SGTech took steps to further Singapore's position as a global node for digital and data with a significant Memorandum of Understanding signing with techUK, a membership organisation in the United Kingdom whose mission is to champion the technology sector

The bilateral agreement, the first for SGTech outside of Asia, opened up opportunities for collaboration both virtually and in the form of physical visits as well.

Foo Chi Hsia, Assistant Chief Executive (International), Infocomm Media Development Authority (IMDA) said of the agreement: "This MOU between techUK and SGTech is a great complement to the UK-Singapore Digital Economy Agreement.

It will facilitate businesses of all sizes to make full use of the Agreement to connect, innovate, and create value through tech and digitalisation – not just between the UK and Singapore, but through Singapore to the fast-growing digital economies in the rest of ASEAN."

The agreement opens up more commercial links on areas such as digital trade facilitation, artificial intelligence, cyber security, digital identities cooperation, and emerging tech.

SGTech and techUK will also focus on joint activities that promote commercial opportunities in areas of mutual interest as well as allow for greater interaction through dialogue on regulatory cooperation in digital and tech issues.

SERIES OF BILATERAL SESSIONS AND VISITS

techUK CEO Mr Julian David and Ms Yean Cheong, Executive Director of SGTech, met virtually on 23 Feb 2022 to kick-off the bilateral cooperation, with more roundtable sessions held in subsequent months to follow up on key opportunities and to discuss concerns that companies in the cybersecurity sector face.

Ms Cheong said: "We are pleased to ink this understanding with techUK, our first MOU with a partner outside of Asia. The UK has traditionally been a home to technological innovation and enterprise – both local startups as well as global companies – and we are excited to have the opportunity to collaborate with and learn from such industry players and leaders through techUK."

The opening of borders brought international delegations to Singapore again. These visiting delegations presented opportunities for SGTech to establish ties to facilitate cross-border initiatives that benefit members, and set the stage for engagements that our members can tap on for partnerships or their overseas expansion.

Our member companies, Unabiz & Sentient.io also shared similar difficulties in penetrating the ASEAN market and they look forward to working on collaborating with KICC in this region.

The B20 Taskforce on Women's Empowerment focused on ways to reverse the disproportionate impact of COVID-19 on women, and to unlock new income generation opportunities.

Underpinned by a broad consensus that the scale of pre-pandemic gender gaps was unacceptable, the paper suggested a comprehensive policy framework to support women along the work-life cycle.

The paper had three main recommendations:

Recommendation 1:

Bringing more women back into the workforce and into the heart of economic activity shaping the future. This includes advocating for gender balance across high-growth, high-impact activities such as the design, development and delivery of health and advanced technologies.

Policymakers would need to mitigate the negative impact of the pandemic on women's economic opportunities by designing gender-responsive measures to ensure that progress made over recent decades towards equality is not lost.

They also need to strengthen the pipeline of women into STEM and other high-growth sectors, which will cultivate an early interest in Science, Technology, Engineering and Math (STEM) and build women's aspirations and skills to increase participation in the most in-demand job roles.

Recommendation 2:

Build an inclusive society and workplace cultures, which dismantle pervasive gender stereotypes. The G20 is advised to boost women's economic opportunities by eliminating legal and cultural barriers to paid work, and actively upskilling female workers.

Policymakers will need to identify current gender gaps, and address the associated social and cultural norms that limit women's opportunities - including unpaid work, occupational segregation, and stereotypes.

There also needs to be a focus on building the relevance and resilience of women's skills - Promote gender equity across business departments and functions; and provide women in roles at higher risk of disruption with specific reskilling and training.

Equally crucial is to eradicate sexual discrimination, harassment, and gender-based violence through targeted education programs. Organisations can also develop support mechanisms to aid reporting of unethical behavior in the workplace.

Recommendation 3:

Create pathways for women into business leadership and ownership. The paper recommends that the G20 should mitigate the barriers that limit the ability of women to advance, lead and start businesses.

Policymakers should target gender parity in senior decisionmaking positions, advocate for and eliminate barriers to women reaching senior decision-making positions, with a focus on comprehensive collection of sex-disaggregated data.

Steps can also be taken to enhance the entrepreneurial potential of women - by building the aspirations and capacity of female entrepreneurs and actively support the financing, scaling, and sustainability of women-owned businesses.


